Assumption of Risk, Release of Liability, and Hold Harmless Agreement

This is a Legal Document, Read Carefully Before Signing

I have been made aware that during my participation in the building, remodeling, renovating, and maintenance of houses (activities) and in those activities associated with such conducted by CAPTC and in travel to participate in the activities, I will be exposed to many risks and dangers. I understand that these risks include, but are not limited to, death, serious neck and spinal injuries which may result in complete or partial paralysis, brain damage, serious injury to internal organs, serious injury to my musculoskeletal system, loss of my hand(s), finger(s), toe(s), arm(s), and leg(s), severe lacerations and cuts which may result in serious and permanent injury, serious injury to and loss of my eye(s), ear(s), or teeth, and serious injury to other aspects of my general health and well-being. I also understand that the risks in participating in the activities include not only the foregoing physical injuries, but also impairment of my future abilities to earn a living, to engage in other business, social and recreational activities, and generally to enjoy life. Understanding these risks, I state that I am physically fit to participate in the activities.

I understand that these injuries may result from certain dangers and risks which are present and which include, but are not limited to, use of building tools and equipment; falling objects from work being conducted overhead; lifting and carrying of building tools, equipment and building materials; falls onto the work surface or falls from elevated work areas; and use of building materials containing hazardous chemicals or sharp pointed surfaces.

In consideration of my being permitted to participate in the activities, and as a condition of the right to participate in the activities, I personally assume all risks incident to such activities. I also waive, release and forever discharge CAPTC and any of its employees or agents from all liabilities, losses, damages or costs of any nature which may arise in connection with my travel to or participation in such activities (including rescue activities associated with the activities), whether caused by the negligence of CAPTC, its employees or agents, or caused by some other means. Further, I hereby agree not to file suit against CAPTC or any of its employees or agents. Finally, I agree to indemnify and hold CAPTC and its employees harmless from all liabilities, losses, damages or costs of any nature which may arise in connection with my travel to or participation in the activities (including rescue activities associated with the activities), whether caused by the negligence of CAPTC or its employees or agents, or caused by some other means.
